### Love in the Program

In the first days and weeks of my sobriety, I was told repeatedly not to get into any new relationships in my first year. Of course, I balked at that. I mean, after all, I was giving up the biggest thing in my life – drinking, which enabled me to "have" barroom afterhour relationships. I had already surrendered the alcohol – now my sponsor wanted me to surrender "LOVE?"

So I rebelled and found someone in the rooms that looked attractive to me. I operated out of my old, established routine of qualities I

needed to look for in a relationship: He had to be cute, good looking, and buff. That was about it! It was not so much based on "who" he was, as "how" he looked and "how" I looked beside him. My picker was clearly broken, but I didn't know that at the time.

Of course the relationship with the A.A. guy I chose didn't work. He was about a year sober and I had three weeks. When I told my sponsor that we were breaking up, I recall that she smiled and then told me that "God was having the last say over my self-will."

I understand now that any decisions I made at that point in my sobriety were made by a woman who was still, emotionally, age 16 – the year I started drinking alcoholicly. That was the year that my emotional growth stopped. So despite the fact that I had gotten older, my needs were still very immature and any decisions I made were based on what I needed, rather than what I could give to a healthy relationship.

In fact, I had no idea what a healthy relationship looked like. The majority of my alliances were people I met in bars while drinking – or as I got older – who I met online. My goals were about immediate gratification and when that stopped happening, the relationship was over. Consequently, my relationships were short-lived, for the most part.

After starting work on the 12 steps of A.A., I knew I had to allow myself room to grow if I wanted to become the person I was meant to be and that meant I needed to stay out of relationships for a while. As I spent more time in service and recovery, taking commitments and giving back to others, I started to change. With those changes, my choices changed and opened up. Later on, I was able to meet someone with whom I spent four pretty good years in a close relationship of love and trust. And while it didn't result in permanency, it was better than anything I had experienced before – and yes, that's without the need to drink to enjoy my intimate time! (Cont. on page 4)

**Vice Chairperson** Andre W. opened the meeting at 7:00 p.m. with *The Serenity Prayer. Scott M.* read "*The Twelve Traditions*". Dawn H., Recording Secretary, accepted a motion for approval of Minutes from December's Intergroup Meeting; the minutes were approved.

**Treasurer** Brian H. said Central Office finished 2012 in the black \$1,338.91. Group donations and Gratitude Month (November) accounted for year-end numbers; however sales were down significantly from the previous year. Brian asked the IGRs to think about fundraising efforts to replace the aging computer system at Central Office. With each meeting of A.A., each phone call from a sponsee, and with each email or story I read about someone being helped in this wonderful, beautiful program, I feel love. # LET GO, LET GROW A Mother's Thoughts on Raising Her Children in Sobriety



I am a garden variety alcoholic; there is nothing special or unique about my character defects. I am selfish and vain, and my ego often gets in the way of my usefulness to others. I ask my higher power on a daily basis to remove these shortcomings. Sometimes I manage to surrender long enough to do some good.

Motherhood affords me endless opportunities to practice the principles of the program. It also tends to bring my character defects right to the surface. I often experience a fear of inadequacy, which I will tend to mask with defensiveness and a spirit of defiance for conventions. Again, there is nothing remarkably unique about this quality.

Like most mothers, I want the best for my child. Normal instincts make me protective, "mother knows best," and all that; but as an alcoholic, my problem is with instincts gone awry. My ego takes everything a few more clicks to the left, and suddenly, I am the *only* one who knows how to care for my child. I want to be the *only* one who teaches him. *All knowledge must spring forth from my bounty!* 

If a well-meaning friend instructs my tot to say, "please" or "thank you," my feathers get a little ruffled. "Are they implying I haven't been teaching my child proper manners?" I wonder. If a family member wrangles him from wandering from the table at a restaurant, I chide, "He's fine. I've got it." I mean, how dare they suggest I do not have control? And if a *stranger*, of all people, offers a warning, like, "oh, watch out! Don't fall!" when he's playing out in public, it just about brings my blood to a boil, to think they have the gall to intimate that I'm not paying enough attention to my child's safety! Me, me, me, it's all about my ego and my fear. It is only by the grace of my higher power and the steps of this program that I do not get into embarrassing fights on playgrounds and in the supermarket.

Of course my sober mind knows this is ridiculous. My child's growth depends greatly on learning, and will only reach his potential through a multitude of lessons, taught by many teachers. My ego wants all the credit, but that does not serve him, or me. Thanks to sobriety, and the steps, I can be there for my child. I can be a wonderful example and a fantastic teacher. And I can step aside and watch him learn from others, too, and feel proud and grateful for his independence.

I still have all my character defects, and they can easily rear their heads when I am trying to run the



show. I am grateful for the tools I have learned in Alcoholics Anonymous, the simple skills necessary for sane living and serenity. Cindy L, La Crescenta, CA.

### The Best Is Yet To Come

Grateful even in the face of life's trials and tribulations

"My name is Craig and I am an alcoholic." That statement tells the reader the most important fact concerning my life—that I have a progressive, fatal disease that if left untreated will result in an untimely death.

I grew up in an upper middle class house where all was seemingly well. My parents behaved almost God-like. It was not intentional that I was unable to see their imperfections. It was just that they were raised in upper middle class families where their respective fathers were doctors who had transferred impeccable behaviors to their offspring.



I didn't pick up my first drink until a year after the big wild rock concert at Woodstock. Three more years at prep school and it was off to college. Divine Providence landed me in a large city with a high concentration of colleges and universities. I remember being dropped off near Boston and finally away from parental control.

I thought I had arrived after all those years of being raised strictly and formally, enduring an early curfew, and rules that hampered my social life. All that was about to change.

The first three years were a blur. It was like one long massive party. The last year and a half, I lived in a fraternity. The partying escalated as a relationship I was in came to an end. I treated my emotional pain with alcoholic oblivion.

I suffered a psychotic breakdown during my senior year. My life would never be the same. I was in a psychiatric hospital for just over two years. Upon release, I went back to my B.P.P. experiment which only lasted 15 months. (That stands for the beer, pot and pizza experiment.)

I lost my mind a second time and returned to the hospital for three more years. Looking back, I realized that I lost any belief that God had anything useful for me and my life.

A few years later, I landed in jail for a third and fourth time. The latter charge was for a felony. In between these criminal charges, I collapsed and was brought back to the hospital.

During some of this time, I lived at one of Hartford's male shelters. The shelter closed early that winter at March's end. This led me to a place where I finally conceded to a power greater than myself on Tuesday, January 12, 1988.

I now have 23 continuous years of sobriety. In more recent times, I have lost both my father and mother. However, the beauty of life's trials and tribulations is that I have been given the gift of sobriety and have been able through difficult events to trudge the Road of Happy Destiny. I will keep coming because the best is yet to come! —*Craig J., Bristol, Conn.*
